Michael Rabbitt Board Member Profile



What attracted you to the position on the PDCN board?

I have had an acquired disability since 1992 (Paraplegia), and have benefited enormously from the advocacy work of others in being able to lead a productive life as a full-time worker and as a father. After retirement I was looking for an opportunity to improve conditions for others with a disability. I was attracted to PDCN because of its mission to help people with a physical disability to live their lives as contributing members of the community.

Where do you feel you can add the most value to PDCN in your role as a Board member?

It's essential that PDCN is run in a businesslike fashion to ensure it is able to provide its vital services long into the future. With my business background I can contribute to the governance of the organisation so that it continues to be in a sound position. I'm hopeful that I'll be a strong voice in making representation to government and the community on what needs to be done to allow people with a disability to lead ordinary lives.

As a person with a disability what is the most important issue for you now?

I'm greatly concerned about the rollout of the NDIS, and about the growing shortage of carers with the skills to look after people with significant disabilities. I am personally frustrated by issues around physical access. Not being able to access an appropriate height adjustable bed in a hospital emergency department. Continually encountering developments that have been approved based on the provision of stairway platform lifts that are then not maintained and are often unavailable. Thoughtless temporary access solutions around city construction sites that are very difficult to negotiate. The new 'temporary' access arrangements at Wynyard Station that require you to wheel a long way up a very steep hill to access an alternative lift. Lack of beach access after discovering on a recent trip that Portugal has 40 wheelchair accessible beaches.

Tell us about the other things that interest you outside the disability sector.

I'm an active member of one of the Communications Brigades in the Rural Fire Service and I assist in Employment and Study clinics at the Wayside Chapel. My family are my great passion and I have a partner and two adult children. I am a keen traveller and with a son teaching in the UK, Europe has been a regular thing for me recently. I am a disheartened but committed supporter of the Newcastle Knights (where I grew up) and I don't get AFL! I love to get together with friends over a pint or two of Guinness or a couple of glasses of red wine.

PDCN Policy and Submission Update

As a systemic advocacy organisation our policy work sees PDCN generate written submissions and participate in frequent advisory committees and face-to-face consultations. The policy work carried out by PDCN aims to influence change in legislation, government policy and community attitudes to ensure the rights and interests of people with disability are upheld and promoted.

PDCN seeks to ensure barriers present in the community that prevent people with disability from achieving full access and inclusion are addressed and removed. We work tirelessly to ensure that the needs of our members - people with physical disability - are considered in the development of government policy, and continual improvements are made in all areas of life, including access to the built environment, education, employment, transport and health.

PDCN's policy work is informed by the views and experiences of our members and ensures we have input into policy and legislative development at local, state and federal levels. PDCN has had a busy year with written submissions made on the following inquiries, reviews or consultations:

- icare Lifetime Care: Lifetime Care and Support Guidelines
- NSW Law Reform Commission: Review of the Guardianship Act 1987 draft proposals
- Department of Social Services: A strong future for supported employment
- Parliament of Australia: Senate Standing committee on rural and regional affairs and transport: the need for regulation of mobility scooters, also known as motorised wheelchairs
- City of Sydney: Social Sustainability Policy and Action Plan
- KPMG (on behalf of the Department of Social Services): Specialist Disability
 Accommodation Pricing and Payments Framework Review
- Department of Social Services: Support School Transport and transition to the National Disability Insurance Scheme
- UNSW Social Policy Research Centre: National Disability Strategy Review
- Parliament of NSW: Inquiry into the implementation of the National Disability
 Insurance Scheme and the provision of disability services in New South Wales
- Productivity Commission: National Disability Agreement Review

PDCN Training and Education Update



Since returning to PDCN as the Education and Operations Manager, I have conducted a fee-for-service workshop for Partners in Recovery in the inner-west. Partners in Recovery's main area of work is psychosocial disabilities. The purpose of the workshop was to educate the support staff working with people who also have physical disability, to ensure their specific needs are considered and supported in their application for NDIS funding.

I have also been working with partner organisations both regionally and in the metropolitan areas to consider suitable locations to conduct Plans in Practice workshops and determine where PDCN may be able to collaborate on Information Linkages and Capacity Building and fee-for-service projects. To date these discussions have been productive and positive, and I look forward to sharing more specific details and workshop locations in newsletters to follow. I also look forward to meeting PDCN members at the upcoming AGM.
